The primary goal of the Illinois Homicide Investigators Association (ILHIA) is to support law enforcement officers and prosecutors by providing professional training, leadership, and resources essential to solving homicide cases and criminal investigations. This Conference will provide attendees with main and breakout sessions that focus on some of the most crucial aspects of homicide and criminal investigations. Instructors from across the country with years of investigative experience will provide practical information for those assigned to investigate homicides, violent crimes and other criminal offenses.
